- Driver - Apparatus Operator Task Force has recommended to adopt the new NFPA 2002 Standard and forwarded this recommendation to the FPC

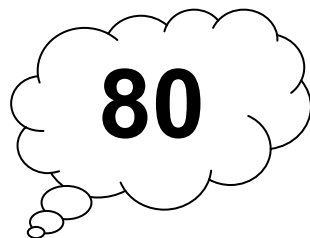
